The Institution / College is fully responsible to fulfil the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of NMC (Erstwhile MCI).

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management Quota as specified by the Medical Council of India / NMC/ KNRUHS.

The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.

The Management of the College shall follow the regulations made by the University/State Government and also Regulations on Graduate Medical Education (Amendment), 2019 of the NMC in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice. This order is valid for the academic year 2022-23 only.

The admissions to the MBBS course are subject to the permission from the NMC, New Delhi, for the academic year 2022-23.
